## Article I: Name and Office Location

### *Section 1: Name*

18 The name of this not for profit corporation shall be the Academy of Science, Engineering and  
19 Medicine of Florida (ASEM-FL)

## Article II: Purpose and Mission

- 43 3. *To bring to the national and international forefront the state of the art research and education conducted in*  
44 *Florida's universities, industries and other educational corporations.*
- 45 4. *To attract into the State of Florida individuals with impactful scientific accomplishments who have attained*  
46 *national and international recognition.*
5. *To enhance collaborations and partnerships of individuals and organizations in the State of Florida who have*  
*common research and educational pursuits, thus breaking geographical barriers for the benefit of the State, the*  
*nation and the global community.*
6. *To inspire the involvement and guide the direction of the future generations in science, engineering and medicine.*

Membership in this corporation shall be open to:


1. Members of the NASEM (National Academies of Science, Engineering and Medicine), who
